Sept. 30 – Nov. 3, 2017 ■ Plymouth, Indiana



ELIGIBILITY: Open to artists in all media. Each entry must be the original concept and work of the artist, completed within the last two years and not previously shown in a Heartland Artist Regional Art Show. Classroom, workshop, or copy work is not allowed. If the artwork is based on a photograph, they must be the artist's own, or used with the permission of the photographer. Final determination of what constitutes eligible work or inappropriate subject matter will rest with the judge and/or Heartland Artists, Inc.

ENTRY PROCEDURE & FEES: Art work accepted for jurying does not guarantee acceptance in the final exhibit. A \$10 non-refundable fee per entry is required, with no limit of the number of entries. Checks or money orders should be made payable and mailed to Heartland Artists, Inc., P.O. Box 714, with a postmark no later than Saturday, Sept. 9, 2017. Entry constitutes permission to publish winners' names.

ENTRY SPECIFICATIONS: Work on paper must be framed and under glass or Plexiglass. Wire hanging systems required on all 2D pieces. 3D art may not exceed 40 lb., or four feet largest dimension. Wall hanging pieces, including groupings may not exceed 48 inches largest dimension. No wet pieces will be accepted. Work submitted without compliance to guidelines will be rejected and entry fees forfeited.

RECEIVING OF WORK: Art work must be hand delivered to: Heartland Artists Gallery, 101 N. Michigan St., Plymouth, Ind. Work will be accepted Sat., Sept. 23, 10:00 - 4:00 p.m. and Sun., Sept. 24, 1:00 - 4:00 p.m.

SALE OF WORK: One entry may be marked "Not for Sale" (NFS); all others must be for sale. A commission of 30% on works sold will be retained by Heartland Artists. Sales tax will NOT be collected on pieces sold. Artists are responsible for including the sales tax amount in the price of their piece and paying it themselves.

UNACCEPTED ARTWORK: Storage space for work *not accepted* is limited. Art work *not accepted* must be picked up no later than 5:00 p.m., Saturday, Oct. 7, unless special arrangements are made with the gallery.
